Social Enterprise Accelerator Boosts Nonprofits' Earned Income Potential Up to \$240,000 in Matching Gifts Will Fuel Eight Organizations' Social Enterprises

The Social Enterprise Accelerator allows nonprofits to develop or grow revenue-generating business ventures that are aligned with their missions, to support the financial sustainability of their organizations. The first group of 10 nonprofits started the program in 2018; the second group of six began in 2021, with eight organizations (the Entrepreneurial Eight) currently engaged in a 2 ½-year process to develop business plans, raise start-up capital and implement their earned income ventures.

The Foundation has created a matching challenge: for every dollar of start-up capital raised by the Entrepreneurial Eight, the Foundation will match dollars raised up to \$30,000. This announcement followed "Fast Pitch" sessions on January 23 and January 24 when organizations presented their business plans to potential donors and made a direct ask for financial support toward startup capital needs. The matching challenge runs through April 24.
